SOME NEW YEAR RESOLUTIONS

Keeping New Year's resolutions is one of the most difficult challenges a human being faces every 365 days. We say we are going to do something, and we fully intend to do it, but something happens along the way and we back off, cease, desist, and sometimes never even start to live into the resolution we made.

The ensuing year of 2026 will involve a resolution that has already begun. North Carolina Scottish Rite is restructuring how we do things as an Orient in North Carolina.

All of us can help if we make and keep a resolution that we Scottish Rite Masons, no matter how difficult that process may be. It involves changing the conversation in Freemasonry so that we can address some truth staring us in the face, but is, too often, overlooked.

Why would we ever suspend a "true brother" for non-payment of dues? The truth is that I cannot think of one good reason it should ever happen, especially if he has been faithful to his trust for many years and has reached the age of eighty. If a "true brother" is in need in any way, brotherly love expects us to help him. On bended knee we promised to help a "true brother" in need. If we are a "true brother" we will do it if possible.

If, however, the brother (note that I omitted the word "true") has a bad attitude toward or bad experience with the fraternity, that causes injury to any other person, then that brother owes it to us to meet on the level, act by the plumb, and part on the square to be "true." When we are too quick to let someone go, we cause more harm than good.

Any departure from the fraternity raises everyone else's dues. You ask, "How's that?" It is simple. Suspensions and demits, for whatever reason, is complicity with increasing the costs of operating the Lodge, Valley, Chapter, Commandery, Council,

Temple, for all "true brothers." You can add to that true knights, true nobles, or whatever "true" term applies in any part of the family of Freemasonry.

A "true brother" is one who keeps his vows and resolutions. He aids and assists another brother in need. He keeps up with him, not by just documenting his attempts through that ever-trustworthy email chain and the US Postal Service, but by mouth-to-ear and hand-to-hand care and concern. A "true brother" does not separate himself from the altar at which he knelt and made his initial resolutions. A "true brother" reminds an erring brother in tender manners of the need for redirection and then aids the reformation instead of making matters worse by condoning practices that makes this fraternal journey more difficult for everyone else.

It is time to change the conversation in North Carolina. It is time we resolved to be more attentive to those we have lost touch with, for whatever reason. It is time for us to understand that growth by subtraction equals lost revenue which drives the costs of Freemasonry upward—and DO SOMETHING positive about it.

Peace, harmony, interest, involvement, and integrity come with genuine caring for instead of about our brothers. Remember we are a brotherhood, not a bargain.

When 2027 gets here, how will we have done? Better yet, how will we help change the conversation?"

Front Cover Brother Spotlight

JOHNNY SURLES AND HIS CONNECTION TO THE D.B. COOPER CASE VIA RICHARD FLOYD MCCOY, JR.

Johnny Surles is a **retired Lieutenant with the North Carolina State Highway Patrol (NCSHP)**, a **U.S. Army veteran**, and a **distinguished Freemason** (notably involved in Scottish Rite activities). He has become a key figure in discussions about the infamous D.B. Cooper hijacking due to his direct involvement in pursuing Richard Floyd McCoy, Jr., a prime suspect in the 1971 Northwest Orient Flight 305 skyjacking—where a man calling himself “Dan Cooper” (later misreported as D.B. Cooper) parachuted from a plane with \$200,000 in ransom, vanishing without a trace.

THE D.B. COOPER CONNECTION

The Bank of North Carolina (BNC) robbery on April 27, 1974, in Pollocksville, NC—often tied to Cooper lore as “D.B. Cooper”. McCoy, who had escaped prison earlier that month while serving time for the second Cooper hijacking, executed a strikingly similar crime: He boarded a plane from Denver to Salt Lake City, passed a note claiming a bomb, demanded \$500,000, and parachuted out mid-flight.




Surles’ Role: As one of the first NCSHP officers on the scene at the BNC robbery, Surles helped investigate the aftermath, including the abandoned car. This led to two of his comrades/friends swift recapture in Cove City and allowed McCoy and Walker to escape. Surles has emphasized the robbery’s eerie parallels to the D.B. Cooper case—same hijack method, parachute escape, and even similar physical descriptions—fueling theories that McCoy was Cooper.

SURLES’ CONTRIBUTIONS TO THE MYSTERY

Surles frequently lectures on the case, arguing McCoy’s guilt based on timelines, skills (McCoy was a skilled parachutist and BYU student), and FBI evidence like matching parachute tie fibers. He appears on podcasts like *The Cooper Vortex* (2020 episode: “D.B. Cooper was a Student at BYU - Johnny Surles”), where he details the BNC pursuit. In a 2012 WRAL-TV segment (“Did D.B. Cooper rob an NC bank?”), Surles recounted the chaos: “We knew that it was McCoy due to the two hijackings were so much alike and evidence found at the scenes.”

The FBI closed the Cooper case in 2016 without confirming McCoy, but Surles’ firsthand account keeps the debate alive. For more, check *The Cooper Vortex* podcast or Surles’ is a speaker on the DB Cooper Connection and travels around the country and is on the Grand Lodge Speakers Bureau.

This saga blends crime and aviation history—Surles embodies the boots-on-the-ground pursuit of America’s greatest unsolved heist.

May the Peace of the Master be with you.



As we move into the New Year, the Brethren of the Charlotte Valley are looking ahead to achieving great things in 2026. But we may also take the time now to look back at the previous year, and celebrate our members and the Masonic labors they have performed.


FAYETTEVILLE REUNIONS

The First Light

AN AMERICAN JOURNEY: LITTLE LODGES ON THE PRAIRIE - FREEMASONRY & LAURA INGALLS WILDER




Many of us may have wonderful memories of growing up and watching TV with the family, before we were overwhelmed with so many choices of channels and shows. One of those shows was Little House on the Prairie, a historical western based loosely on the life and books of Laura Ingalls Wilder, and which ran for nine seasons. Today, one could correctly refer to that show as “pure Americana”. However, look more deeply into the past and the life of Laura and you will find a fascinating link to Freemasonry, the Order of the Eastern Star and the settling and opening up of the American countryside. This is exactly what Ms. Teresa Lynn has done with her book “Little Lodges on the Prairie: Freemasonry & Laura Ingalls Wilder”.

On 13 September 2025, members of the Valley of Franklin and Junaluskee Lodge #145, AF&AM, of Franklin, NC, hosted Ms. Lynn and her husband, David Lynn, 32°, to talk about her book and her journey researching the Ingalls and Freemasonry. The genesis of the book started when she overheard a conversation between her husband and his brother, a Mason and Shriner. Her husband was inquiring about beginning his journey in search of Light, and being the researcher that she is, this started her journey looking into what Freemasonry was. During this research, she came across a list of famous Masons which included Laura Ingalls Wilder! Being taken aback, wondering how a woman’s name was on such a list, she looked again and saw an asterisk that led her to the footnote stating that Laura was not a Mason, but a member of the Order of the Eastern Star. She further noted that the compiler of the list was not aware of who in Laura’s family was a Mason, which allowed her to become an Eastern Star. It was with this notation that set Ms. Lynn on the journey that was to become the book here referenced.

The book is well written and researched, giving the reader a concise background in Freemasonry and the Order of the Eastern Star. It also provides a good biographical grounding in the life and times of Charles and Caroline Wilder and their children Mary, Laura, and Carrie. Ms. Lynn shows the connection between the family and the settling of many communities across the Nation, the construction of churches and lodge buildings; the establishing of businesses and the oft harshness and hardships faced by the Wilders, and others, and their perseverance in adapting to these conditions.

What is fascinating to the author of this article is the direct ties that the Wilder family had in many Lodges, and in particular, the naming of what would become a most iconic American landmark. It seems that little Carrie, the youngest daughter whom in mind will always be the young actresses Lindsey and Sidney Greenbush seen tumbling down the hill in the opening of the TV show, worked for a newspaper in Keystone, SD. There she met and married David N. Swanzey, a brother mason. Brother Swanzey worked for the CB&Q Railroad and had a strong interest in mining. He soon became a noted expert in the local geology in the area. A young New York attorney made several visits to the area in 1884 to scout out possible locations for mining investments. He was guided by Brother Swanzey in these scouting adventures and it was on one such trip that they came to be near a particular hill, known to the locals by such names as Keystone Cliffs, Sugarloaf Mountain, and other names, but not having an official name. This attorney asked for its designation and Brother Swanzey stated, “We’ll name it after you”! Thus a piece of land would get a name that 57 years later would become an iconic landmark. That attorney’s name was Charles Rushmore.
